# WHAT ARE THE KEY EHR REQUIREMENTS FOR BEHAVIORAL & MENTAL HEALTH PRACTICES?

Needless to say, behavioral and mental health practices face a challenging set of requirements when selecting EHR software.

These include:

- **Complex treatment plans:** treatment plans are often long-term, and can take into account personal background, living situation and socio-economic factors. They may comprise a mixture of talking therapies, medication and input from other providers.
- **Patient non-compliance:** mental and behavioral health patients have a high rate of non-compliance due to the nature of their illnesses and the life situations that accompany them.
- **Patient confidentiality:** mental health practices need to meet key compliance requirements regarding patient data, so should be looking for vendors with a good track record of data security and reliable storage
- **Accommodation of multiple facility types:** clinicians treat mental health patients as inpatients, outpatients and everything inbetween.

# WHICH MENTAL HEALTH EHR FEATURES DO YOU NEED?

### **CORE MENTAL HEALTH EHR FEATURES**

Core mental health features are essential in creating and coordinating complex treatment plans. These will typically include:

- Lab integration
- E-prescription of controlled substances
- Flexible charting
- Easy-to-use patient portal
- Appointment scheduling and reminders
- Meaningful Use/HIPAA compliance

### **ADVANCED MENTAL HEALTH FEATURES**

These might increase the overall cost of the system, but should be considered for the efficiency benefits they offer your clinicians:

- Hands-free notes
- Specialty-specific menus and intake forms (e.g Sadness Scale, suicidal/violent risk factors)
- Medication management with harmful drug alerts
- Specialty billing

### **HOW MUCH DOES EHR COST?**

Studies pitch the TCO of purchasing and implementing a general EHR between \$15,000 and \$75,000 (average \$45,000) per provider depending on deployment model/size of practice

### HOW MUCH DOES CLOUD BEHAVIORAL HEALTH EHR COST?

A survey of popular behavioral health EHR vendors pitches the out-of-box price at \$30-\$150 per clinician per month (average \$90 per clinician per month)

\$1,500

### HOW MUCH DOES ON-PREMISE BEHAVIORAL HEALTH EHR COST

One-time fees tend to vary from around \$500 per practitioner to \$2,500 per practitioner (average \$1,500)

## **HOW MUCH DOES BEHAVIORAL AND MENTAL HEALTH EHR COST?**

### **HIDDEN COSTS**

Beware - hidden costs can increase the out-of-box prices quoted above significantly. When budgeting, ensure you factor in:

- Updating hardware (for on-premise systems)
- Implementation services/consultancy
- Staff training
- Productivity loss during implementation
- Staff overtime during implementation
- Updates/upgrades

### **EHR SOFTWARE TCO**

**\$48,000:** five year TCO of an on-premise EHR

**\$58,000:** five year TCO of a cloud-based EHR

Prices sometimes vary depending on number of prescribing and non-prescribing users - so it's essential to have a good idea of who your user base will be before starting to budget.
